### Cancellation Policy

#### **Cancellation Penalties:**

- From time of deposit – December 20, 2009 - \$150 per person
- December 21, 2009 – January 12, 2010 - \$600 per person
- January 13 - February 10, 2010- 50% of cruise fare plus \$250 administrative fee per person
- February 11, 2010 – Day of Departure: Nonrefundable

### Protection / Travel Insurance Options

There are two optional types of plans that may be selected to protect your cruise investment.

#### **1) Holland America's CPP Standard Protection Plan (Covers cruise portion only)**

**Holland America's CPP Protection Plan can be added to your cruise booking up to the final payment date of December 21, 2009.** It will allow you, **for any reason**, to provide written cancellation up to 24 hours prior to sailing and receive a refund equal to 80% of the applicable cancellation fee. Plus, Holland America assumes an additional US \$500 liability for lost, damaged or delayed baggage. This plan is not a travel insurance program, and **does not** cover anything other than explained above. For example, it does not protect double-triple-quad occupancy rates should one or more of your party cancel, nor does it cover expenses or unused services due to trip interruption.

#### **2) Travelex Travel Plus Insurance Plan \*Highly recommended\***

This plan will cover trip cancellation, trip interruption or delay, accident/medical expenses, and baggage. Rates vary based on age and cost of the cruise. Acceptable reasons for canceling are mostly for **major medical illnesses or a death in the family**. Please see FAQ (frequently asked questions) at the bottom of the home page of Travelex for additional clarification. Purchasing this protection must be handled directly with Travelex. **This coverage must be taken out within 21 days of deposit to cover any "pre-existing" conditions.** It will cover all travel expenses including seminar fees if those costs are added into the total coverage.
